Will the Minister of WATER RESOURCES, RIVER DEVELOPMENT AND GANGA REJUVENATION be pleased to state:

- (a) the present status of various projects under Namami Gange Mission alongwith the proposed tenure of the completion of the projects, State-wise;
- (b) the major works envisaged thereunder including financial cost involved therein;
- (c) whether any State Government has submitted more projects in this regard, if so, the details thereof and the action taken thereon;
- (d) the quantum of total expenditure incurred under the mission so far; and
- (e) whether the Government has any plan to extend/implement such projects in other parts of the country too and if so, the details thereof?

ANSWER

THE MINISTER OF STATE (IC) FOR YOUTH AFFAIRS & SPORTS AND MINISTER OF STATE FOR WATER RESOURCES, RIVER DEVELOPMENT AND GANGA REJUVENATION (SHRI VIJAY GOEL)

- (a) & (b) The various types of pollution abatement schemes taken up to clean Ganga are categorized into 'entry level activities'; 'medium term activities'; and 'long term activities'. There are 273 projects under Namami Gange Programme and are under different stages of implementation. All the projects are planned for completion by 2020. The status of the projects as on 30th September 2016 is given under **Annexure-1**.

- (d) The expenditure incurred during 2014-15 and 2016-17 (upto 10.11.2016) is Rs.3,585.90 crores.
- (e) Pollution abatement schemes for rivers other than Ganga Basin is handled by the Ministry of Environment, Forest & Climate Change through its National River Conservation Directorate (NRCD) Programmes.
