2. We have sought comments from NCERT, CBSE, NITI Aayog, AS (SE) and JS (SE-1) for preparing reply to the aforesaid Question. Responses from NCERT and NITI Aayog have been received. NITI Aayog has informed that no such Evaluation Study has been carried out by Development Monitoring & Evaluation Office (DMEO) (erstwhile Plan Evaluation Organization), NITI Aayog, during last few years. NCERT have stated that they have no information to furnish.
