Will the Minister of HOUSING AND URBAN POVERTY ALLEVIATION be pleased to state:

- (a) the total number of State Level Technical Cells and City Level Technical Cells created till now, State-wise;
- (b) whether the Government intends to sanction the creation of State Level Technical Cells and City Level Technical Cells under Pradhan Mantri Awas Yojana to the State of Rajasthan;
- (c) if so, the details thereof along with time-frame, if any; and
- (d) if not, the reasons therefor?

(a) : As on 09.12.2016, approval for establishment of State Level Technical Cell (SLTC) for 24 States and total 583 City Level Technical Cells (CLTCs) for 24 States have been accorded by this Ministry under Pradhan Mantri Awas Yojana (Urban) [PMAY (U)] Mission. State-wise details of SLTC and CLTCs are at Annexure.

(b) to (d): Approval for establishment of one SLTC and 33 CLTCs for the State of Rajasthan have been accorded under PMAY (U) Mission by this Ministry. Further, 1st instalments of Rs. 0.33 crores for establishment of SLTC and Rs. 2.18 crores for establishment of CLTCs have also been released to the State of Rajasthan.
