HOUSES FOR MIDDLE CLASS FAMILIES

No. 4456 SHRI G.M. SIDDESHWARA:

Will the Minister of HOUSING AND URBAN POVERTY ALLEVIATION be pleased to state:

(a) whether the Government is seriously contemplating to provide houses to middle class families in Delhi and other parts of the country;

(b) if so, the details thereof, State-wise including Karnataka; and

(c) the number and the names of the cities where it is contemplating to provide such houses and if not, the reasons therefor?

ANSWER

(a) to (c): In pursuance of the Government's vision of facilitating housing to all by 2022, the Government has launched Pradhan Mantri Awas Yojana (Urban) [PMAY(U)] Mission on 25.6.2015. All the Statutory towns across the country as per Census 2011 and towns notified subsequently are eligible for coverage under the Mission.

The Mission aims to provide assistance to all States/UTs in addressing the housing requirement of the urban poor including slum dwellers [Economically Weaker Sections (EWS)/Low Income Group (LIG) Categories] through following four verticals:

(i) "In situ" Slum Redevelopment through private participation using land as resource (ISSR);

(ii) Credit Linked Subsidy Scheme (CLSS);

(iii) Affordable Housing in Partnership (AHP); and

(iv) Subsidy for Beneficiary-Led individual house Construction or enhancement (BLC).

ISSR, AHP and BLC components of the Mission are centrally sponsored Schemes. As on 5.12.2016, State/UT-wise (including the State of Karnataka) details of no. of cities included under the Mission and no. of houses involved under these components are at Annexure.

The CLSS component of the Mission is central sector scheme and hence is applicable to all the statutory cities/towns.
