**Allocation of Coal Blocks**

**4633. SHRI NALIN KUMAR KATEEL:**

Will the Minister of COAL be pleased to state:

- (a) whether the Union Government has received any proposal from the various State Governments including Karnataka for allocation of coal blocks;
- (b) if so, the details of proposals received during the last three years, Statewise; and
- (c) the details of proposals cleared and pending out of them and the reasons for their pendency along with the time by which the pending proposals are likely to be cleared, State-wise?

(a) to (c): Requests have been received from time to time from various State Governments including Government of Karnataka for allocation of coal mines. The allocation of coal mines are now made under the provisions of the Coal Mines (Special Provisions) Act, 2015. The State Government companies may apply as and when applications are invited by Ministry of Coal / Nominated Authority through a Notice Inviting Application (NIA) for allocation of coal mines. Applications, if any, shall be considered as per the norms specified. The details of mines allotted under the Act to State Public Sector Undertakings is at Annexure.
