UTILISATION OF FUNDS UNDER NRLM

4819. SHRI BAIJAYANT JAY PANDA:

Will the Minister of **RURAL DEVELOPMENT** be pleased to state:

- (a) whether the Government is aware of the fact that the 1st instalment of the Union share to Odisha under the National Rural Livelihoods Mission (NRLM)/ National Rural Livelihoods Programme (NRLP) for 2015-16 has not been released despite requests from the Government of Odisha and if so, the details thereof along with the time by which this first instalment is likely to be released and if not, the reasons therefor;
- (b) whether the Government has accepted the request of Odisha to release an additional fund of Rs. 6264.20 lakhs under NRLM and NRLP;
- (c) if so, the details thereof and the time by which this additional fund is likely to be released and if not, the reasons therefor;
- (d) whether the Government is also aware of the fact that the Odisha has made requisition for a fund of Rs. 3.92 crore under Rural Self Employment Training Institutes (RSETIs);
- (e) if so, the details thereof and the time by which the fund is likely to be released; and
- (f) if not, the reasons therefor?

ANSWER

(a) to (c): During the financial year 2015-16, a sum of Rs. 2388.45 lakh was allocated to Odisha for implementation of Deendayal Antyodaya Yojana – National Rural Livelihoods Mission (DAY-NRLM), The details of Central share released to Odisha during 2015-16 under DAY – NRLM and National Rural Livelihoods Project (NRLP) is as follows:

Total	937.02	3836.00

As stated above, a sum of Rs. 2346.00 lakh was released to Odisha as third/additional instalment under NRLP during 2015-16 against the request for release of Rs.2563.00 lakh received from them. There was no request for additional instalment under DAY - NRLM.

(d) to (f): Yes, Madam. A request was received from Odisha for release of Rs. 3.92 crore as 1st Installment of support for Rural Self Employment Training Institutes (RSETIs) for the financial year 2015-16. Against this requisition, a sum of Rs. 2.21 crore has been released after taking into account the funds utilized by Odisha.
