#### DEVELOPMENT OF FOREST VILLAGES

#### †723. SHRI ALOK SANJAR: SHRI GOPAL SHETTY:

Will the Minister of TRIBAL AFFAIRS be pleased to state:

(a) the total number of tribal villages at present in the country, State/UT-wise including the norms for declaring a village as a tribal village;

(b) whether any specific programme for development of forest villages has been implemented by the Government;

(c) if so, the details thereof along with the amount of funds allocated, released and utilized for the development of forest villages during the last three years and the current year, State/UT-wise;

(d) the number of forest villages/ habitations in various parts of the country, State/UT-wise along with the details of forest villages developed at present;

(e) the number of persons benefited so far along with the time by which the remaining forest villages are likely to be included under the scheme; and

(f) the other steps taken/being taken by the Government towards development of various forest villages in the country?

#### ANSWER

# MINISTER OF STATE IN THE MINISTRY OF TRIBAL AFFAIRS (SHRI JASWANTSINH BHABHOR)

(a) This Ministry does not maintain data/information about number of tribal villages. Neither this Ministry has prescribed any norms for declaring a village as a tribal Village. However, this Ministry has issued guidelines, in compliance of Section 3 (1) (h) of "The Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006, on conversion of forest villages, old habitations, unsurveyed villages in forests, whether recorded, notified or not into revenue villages vide letter No.23011/33/2010-FRA dated 08.11.2013. Status of conversion of Forest Villages to Revenue Villages based on the information received from the State Governments is at <u>Annexure-1</u>.

(c) Ministry of Tribal Affairs had implemented a programme for development of forest villages since 2005-06 as a one-time measure for integrated development of forest villages with a view to raise the Human Development Index (HDI) of the inhabitants of the forest villages and for providing basic facilities and services in forest villages/habitations in the country. The programme included infrastructure works relating to basic services and facilities viz. approach roads, healthcare, primary education, minor irrigation, rainwater harvesting, drinking water, sanitation, community halls, etc. and activities related to income generation. The programme was implemented as a part of the Special Area Programme 'Special Central Assistance to Tribal Sub-Plan" and funds were released from the year 2006-07 to 2011-12 only. No fund has been released during 12<sup>th</sup> Five Year Plan period.
