Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION उपभोक्ता मामले, खाद्य और सार्वजनिक वितरण मंत्री be pleased to state:

- (a) whether the Government proposes to use Smart Card Technology in the Public Distribution System (PDS) and if so, the details and the objectives thereof;
- (b) whether the Government has consulted the States in this regard and if so, the response of the States thereto;
- (c) the other steps taken by the Government for effective implementation and bringing transparency in PDS;
- (d) whether the Government has taken a decision to set up shops under PDS in all wards of Gram Panchayats all over the country; and
- (e) if so, the number of Panchayats in the country where this scheme has been implemented, State-wise?

STATEMENT REFERRED TO IN REPLY TO PARTS (A) TO (E) OF THE STARRED QUESTION NO. 167* DUE FOR ANSWER ON 14.03.2017 IN THE LOK SABHA

- (a) & (b): No, Madam.
- For effective implementation and bringing transparency in Public Distribution System (PDS), Government has initiated implementation of a Plan scheme on "End-to-end Computerization of Targeted Public Distribution System (TPDS) Operations" during 12th Five Year Plan (2012-17). The component-I of the scheme comprises digitization of ration cards/beneficiary and other databases, online allocation, computerization of supply-chain management, setting up of transparency portal and grievance redressal mechanisms. Besides, Central Govt. has also asked States/UTs to opt for any of the two models of Direct Benefit Transfer -Cash transfer of food subsidy into the bank account of beneficiaries or fair price shop (FPS) automation, which involves installation of Point of Sale (PoS) device at FPS, for authentication of beneficiaries and electronic capturing of transactions. The cash transfer of food subsidy is being implemented in 3 UTs namely Chandigarh, Puducherry w.e.f. 01-09-2015 and partially in Dadra & Nagar Haveli w.e.f. 01-03-2016. For remaining areas, States/UTs have been asked to expedite the pace of Fair Price Shop (FPS) automation. So far, more than 1.78 lakhs FPSs are automated across the country. A statement showing the progress made under 'End-to-end Computerisation of TPDS Operation' is at Annexure.
- (d) & (e): Under NFSA 75% of the rural population and 50% of urban population totalling 67% of the total population of country i.e. 81 crores beneficiaries are covered. All the gram panchayats of the country are covered under the NFSA and the scheme. A total of 5.26 lakh FPSs are operational across the country. As per clause 9 of TPDS (Control order), 2015, the license to FPS shall be issued by State Government and preference shall be accorded to public institutions or public bodies such as panchayats, self help groups, cooperative societies in licensing of fair price shops and management of fair price shops by women or their collectives. Besides, the State Government shall ensure that the number of ration card holders attached to a fair price shops are reasonable, the fair price shop is so located that the consumer or ration card holder does not have to face difficulties to reach the fair price shop and that proper coverage is ensured in hilly, desert, tribal and such other areas difficult to access.
