- (a) the foreign funds received by various companies in the country for the infrastructure projects during the last two years, State / UT-wise;
- (b) the names of companies which have spent more than five hundred crore of rupees of foreign funds on the infrastructure projects during the said period, State/UT wise; and
- (c) the number of employment opportunities generated as a result thereof?

STATEMENT AS REFERRED TO IN REPLY TO PARTS (a) TO (c) OF LOK SABHA STARRED QUESTION NO. *496 FOR ANSWER ON 7TH APRIL 2017 REGARDING "FOREIGN FUNDS FOR INFRASTRUCTURE PROJECTS".

The Government of India has put in place a robust foreign investment policy to attract foreign investment. The policy is reviewed on an annual basis, keeping in view, among other factors, the employment potential of the different sectors. The infrastructure sector has attracted USD 24,287 million into the country, which stands at approximately 8% of the total foreign investment received in India. The infrastructure sector has received an inflow of USD 769 million, USD 113 million and USD 99 million during 2014-15, 2015-16 and 2016-17 respectively. The statement indicating State-wise inflows of foreign investment in the infrastructure sector is as under:
