DEVELOPMENT OF SLUMS

No. 88. SHRI B.V. NAIK:
DR. VIRENDRA KUMAR:

Will the Minister of HOUSING AND URBAN POVERTY ALLEVIATION be pleased to state:

(a) the number of slums and the population of slum dwellers in the country, State-wise;

(b) the number of slums demolished during the last three years and the amount of compensation disbursed, State-wise and year-wise;

(c) the fund disbursed for construction of low cost housing during the last three years and the number of houses constructed, State-wise and year-wise;

(d) whether the percentage of slum population has changed over the last three times of data collection at All India and State levels and if so, the details thereof; and

(e) the programmes and schemes run by the Ministry for slum development, rehabilitation and improvement of socio-economic conditions of slum dwellers and funds allocated for the same during the last three years, State-wise?

STATEMENT

STATEMENT REFERRED TO IN REPLY TO LOK SABHA STARRED
QUESTION NO. 88* FOR 08.02.2017 REGARDING "DEVELOPMENT OF
SLUMS"

(a): As per NSSO Report on "Urban Slum in India-2012", the total estimated no. of slums in the country is 33,510. As per Census-2011 data, the slum population is 6,54,94,604.

(b): Housing, land & colonisation being State Subject, the demolition of slums and compensation thereof comes under the purview of State Governments.

(c): State/UT-wise and year-wise details of fund released and houses constructed during the last three years under the Schemes of Jawaharlal Nehru National Urban Renewal Mission (JNNURM), Rajiv Awas Yojana (RAY) and Pradhan Mantri Awas Yojana (Urban)[PMAY(U)] is at Annexure-1.

(d): As per the Census 2001 data, slum population was 18.30% of total urban population in the country. As per Census 2011, this is 17.4%. State-wise Urban Population, Slum Population and percentage of Slum Population in urban population during Census 2001 and 2011 are at Annexure-2.

(e): The Central Government through its schemes provides assistance to States/UTs in addressing the housing requirement of the slum dwellers and urban poor. To achieve this goal, Government of India had implemented the JNNURM with two components viz. Basic Services to the Urban Poor (BSUP) and Integrated Housing and Slum Development Programme (IHSDP).

Mission duration was 7 years from 2005-06 which has been extended upto March, 2017 for completion of projects sanctioned upto March, 2012.

Government also implemented Rajiv Awas Yojana (RAY) for providing houses along with basic civic and social infrastructure for slum dwellers and urban poor. Rajiv Awas Yojana has been discontinued and liabilities against 183 ongoing RAY projects have been subsumed in PMAY-HFA (U).

In pursuance of the Government's vision of facilitating housing to all by 2022, the Government is implementing PMAY(U). The Mission aims to provide assistance to States/UTs in addressing the housing requirement of the slum dwellers and urban poor.

State-wise details of the fund sanctioned during last three years under JNNURM, RAY & PMAY(U) Mission is at Annexure-3.
