**LAUNCH OF PMKVY PHASE II**

**1015. SHRIMATI SANTOSH AHLAWAT:**

**Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:**

- (a) whether the Government proposes to launch Pradhan Mantri Kaushal Vikas Yojana (Phase-II);
- (b) if so, the details thereof indicating the features included in it to remove the shortcomings noticed in the Phase-I;
- (c) whether some organisations were allegedly found involved in corrupt practices during PMKVY-I; and
- (d) if so, the details thereof and the action taken thereon?

**ANSWER**

(a) and (b) Yes Madam, the Union Cabinet approved the PMKVY (2016 – 2020) scheme on 13<sup>th</sup> July, 2016 with an aim to provide skill training and certification to 10 Million candidates in next 4 years with the outlay of 12,000 crore.

The salient features of the modified PMKVY (2016-20) includes NSQF based quality assurance framework, alignment with common norms, market relevant training programmes, recognition of prior learning, curriculum alignment, national certification, employable skills, placements etc. Under the modified scheme, the focus on employment has been significantly enhanced. Scheme incentivizes Training Centers (TCs)/ Training Partners (TPs) for facilitating placement of the trained candidates. TCs are mandated to organize placement/rozgar melas every six month with the support of Sector Skill Council. Various IT interventions such as Direct Benefit Transfer, Aadhaar linkage of trainers and trainees, Biometric attendance of candidate, SMART portal based Accreditation & Affiliation of TCs etc have been ensured. Additionally, there is a special provision in the scheme to provide post placement support to women, PwDs and candidates from special areas (LWE, North East region and J&K).

(c) and (d) The list of Training Partners/Centres suspended during PMKVY 2015-16 is at **Annexure-I**.

In order to mitigate corrupt practice, MSDE has modified PMKVY in 2016. For effective implementation of PMKVY, complete transparency and accountability are maintained through various IT interventions. The scheme has provisions for high standard monitoring of TCs/TPs. The assessment agencies empanelled by Sector Skill Councils would adopt various methodologies such as self-audit reporting, call validations, surprise visits, and monitoring through the Skills Development Management System (SDMS) for continuous monitoring. Training Partners/SSCs would be penalized at rate of 1% of training cost or assessment fees for every single day delay in assessment.
