FOOT OVERBRIDGES ON NATIONAL HIGHWAYS

Will the Minister of ROAD TRANSPORT AND HIGHWAYS

- (a) whether the Government has undertaken work relating to widening and development of National Highways;
- (b) if so, the details thereof and the funds allocated therefor;
- (c) whether the National Highways Authority of India (NHAI) proposes to build foot overbridges to check fatalities on National Highways and make the journey on them smooth; and
- (d) if so, the details thereof indicating the number of foot overbridges to be constructed and funds allocated, State-wise?

(a) to (b) Yes Madam. About 1180 nos. of work relating to widening and development of National Highways (NHs) are ongoing. State-wise & scheme-wise allocation of funds for widening and development of National Highways are at Annexure-I.

(c) to (d) Yes Madam. 443 numbers of Foot Over Bridges (FOBs) are proposed to be constructed all over the country on NHs by NHAI in a phased manner depending upon the inter-se-priorities of works, fulfilling the technical requirements and availability of funds. No separate State-wise funds are allocated for FOBs.
