# THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI M. J. AKBAR)

The Prime Minister of Portugal Mr. Antonio Costa visited India from January 6-12, 2017 on a State Visit at the invitation of Prime Minister Narendra Modi. The two Prime Ministers held talks in New Delhi on 7 January 2017. The two sides discussed bilateral, regional and international issues of common interest including areas of cooperation in trade and investment, defence, science and

technology, renewable energy, marine resources, IT and agriculture. They also discussed global issues including UNSC reforms and fight against terrorism. Prime Minister Costa was the Chief Guest at Pravasi Bharatiya Divas 2017 in Bengaluru on 8-9 January 2017 and he was awarded the Pravasi Bharatiya Samman by the President on 9 January 2017. He was the special guest at Vibrant Gujarat Global Summit at Gandhinagar on 10 January 2017. He visited Goa on January 11-12, 2017.

(c) to (e) Seven Government-to-Government MoUs were signed in the areas of defence, renewable energy, marine research and resources, agriculture and allied sectors, information technology and electronics, agreement on exemption of visa for holders of diplomatic passports and establishment of ICCR Chair in Lisbon University. The two sides also issued a Joint Declaration on Cooperation in Third Countries to encourage private sectors of the two countries to identify and mutually support collaborative projects and economic activities.
