(a): Government has provided assistance for setting up of Common Facility Centres under Infrastructure Technology support for development of handicrafts.

(b) to (e) : Government of India has sanctioned a special project under "Integrated Development and Promotion of Handicrafts" for an amount of Rs. 20.38 crores in the state of Tamil Nadu benefitting 19450 artisans. List of components sanctioned under this project is at **Annexure-I**. Rs.10.19 crores has been released in the year 2015-16.
