Special Assistance under NRDWP

†1225. SHRI NIHAL CHAND:

Will the Minister of DRINKING WATER AND SANITATION be pleased to state:

- (a) the details of the works done by the Government under National Rural Drinking Water Programme, State-wise;
- (b) whether Government is considering to provide special assistance to the States to solve the drinking water problems and scarcity in rural areas; and
- (c) if so, the details thereof and the time by which this special assistance is likely to be provided?

ANSWER MINISTER OF STATE FOR DRINKING WATER AND SANITATION (SHRI RAMESH CHANDAPPA JIGAJINAGI)

- (a) Water is a State subject. This Ministry provides technical & financial assistance to States Governments for improving the coverage of safe drinking water supply of at least 40 litres per capita per day to rural population through centrally sponsored scheme National Rural Drinking Water Programme (NRDWP). With this, the coverage has increased from 70.11% as on 01.04.2011 to 77.24% as on 05.02.2017. State-wise details of present coverage is at Annexure.
- (b) & (c) Allocation of funds under NRDWP to states is based on a pre-approved criteria with weightage as under through which special assistance to some special category is given:
