#### CONSTRUCTION TENDER PROCESS FOR NATIONAL HIGHWAYS

1286. SHRI UDAY PRATAP SINGH:

### Will the Minister of ROAD TRANSPORT AND HIGHWAYS सडक परिवहन और राजमार्ग मंत्री

be pleased to state:

- (a) the number of National Highways (NHs) in the country for which construction tender process has been completed but construction work has not been started;
- (b) the reasons for the said delay in the construction work;
- (c) the present status of the NH-12 of Madhya Pradesh along with the reasons for its continued dilapidated condition;
- (d) whether the Government has fixed any time limit for the construction of the said stretch of NH-12; and
- (e) if so, the details thereof and if not, the reasons therefor?

## ANSWER THE MINISTER OF STATE IN THE MINISTRY OF ROAD TRANSPORT AND HIGHWAYS

(SHRI PON. RADHAKRISHNAN)

- (a) to (b) In about seventy eight numbers of projects, start of construction work is delayed mainly due to forest clearance, land acquisition, non-fulfillment of the condition precedent, financial closure, non-availability of encumbrance free land, poor mobilization of contractor, etc.
- (c) to (e) The development of NH-12 in Madhya Pradesh is being carried out in seven packages with construction period of 24 months and the status is given at Annexure-I.
