SILT DEPOSITS IN GANGA RIVER

Will the Minister of WATER RESOURCES, RIVER DEVELOPMENT AND GANGA REJUVENATION be pleased to state:

- (a) whether a committee has been constituted under the Chairmanship of Shri Chitle to study the problem of silt deposits in river Ganga owing to Farrakka Dam;
- (b) if so, the composition of the said committee and the works undertaken by it in this regard so far;
- (c) whether the committee has visited the locations of silt deposits and if so, the details thereof; and
- (d) whether any report has been submitted by the committee thereafter, if so, the details thereof and the follow up action taken thereon?

(b) The Committee consists of:

- i. Shri Madhav Chitale (Expert Member, NGRBA): Chairman;
- ii. Secretary, Ministry of Water Resources, River Development & Ganga Rejuvenation: Member;
- iii. Secretary, Ministry of Environment, Forests & Climate Change: Member &
- iv. Dr. Mukesh Sinha, Director, CWPRS, Pune: Member Secretary.

The Terms of Reference (ToR) of the Committee is as follows:

- i. To establish need for desilting for ecology and e-flow of the river;
- ii. To form guidelines for works on desiltation from Bhimgauda (Uttarakhand) to Farakka (West Bengal) and will provide necessary approvals for desiltation works;
- iii. To complete the report within three months.

So far, 3 meetings of the Committee have been held and a draft report titled "Report of the Committee constituted for preparation of guidelines for works on desiltation from Bhimgauda (Uttarakhand) to Farakka (West Bengal)" has been circulated on 20-12-2016 to concerned Ministries/ State Governments.
