- (a) whether the export of Jute is decreasing while import of jute is increasing in the country;
- (b) if so, the details thereof and the reasons therefor;
- (c) the quantity and value of jute produced during each of the last three years and the current year, State-wise;
- (d) whether the Union Government is aware that only one jute processing industry is functioning in Assam even though the State is producing huge quantum of raw jute;
- (e) if so, whether the Government proposes to setting up of more jute processing industries in Assam; and
- (f) if so, the details thereof and if not, the reasons therefor?

As may be seen from the above, there is no decline in the exports during the current year. However, owing to a shortfall in the domestic crop of raw jute in the Jute year 2015-16, ending on 30th June, 2016; there has been an increase in raw jute import in the above period.
