### **MUDRA** Loan

## 1701. SHRI B. SRIRAMULU, SHRI RABINDRA KUMAR JENA; and SHRI K.C. VENUGOPAL:

Will the Minister of FINANCE be pleased to state:

- (a) the details of the achievements of the MUDRA scheme along with the positive impact of the scheme on the MSME sector;
- **(b)** whether Mudra Banks have disbursed below Rs. 2000 crore to banks and micro finance institutions so far out of Rs. 20000 crore corpus;
- (c) if so, the details thereof and the reasons therefor; and
- (d) the details of beneficiaries under the MUDRA scheme and the number out of them being Start Up MSME's, state/UT-wise?

#### ANSWER

## THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI SANTOSH KUMAR GANGWAR)

- (a) Rs. 249775.31 crores worth of loans have been disbursed to 6.53 crore borrowers under Pradhan Mantri Mudra Yojana (PMMY) since 8<sup>th</sup> April 2015 till 03<sup>rd</sup> March 2017. The PMMY has facilitated various changes in the landscape for lending to the Micro Small and Medium Enterprises (MSME) sector. These, inter-alia include, increased access to credit for the informal sector, facilitating timely working capital through Mudra Credit Card, helping build up credit histories of a large number of individual borrowers, reduced cost of credit to borrowers of Micro Finance Institutions (MFIs) and Banks through refinance, supporting banks and MFIs to increase credit off-take to small and first time businesses through credit guarantee etc.
- **(b) &(c)** Micro Units Development & Refinance Agency (MUDRA) Ltd has so far drawn Rs. 6,250 crore from Priority Sector shortfall and extended refinance of Rs.4801.06 crore (Rs.3494.81 crore to Public Sector Banks, Rs.339.25 crore to Regional Rural Banks and Rs.967 crore to MFIs.) out of this.
- **(d)** The details of borrowers (state/UT-wise) under PMMY are **annexed**. Data in respect of Start Up MSME is not maintained.
