Will the Minister of COMMUNICATIONS be pleased to state:

- (a) whether the Government has taken cognizance of the reported incidents of the use of smuggled Sim Box being used by terrorist organizations aiding espionage and facilitating hawala transactions in the country;
- (b) if so, the details thereof and the action taken by the Government in this regard;
- (c) whether over sixty parallel illegal phone exchanges were allegedly being operated across the country facilitating the aforementioned illegal activities as per recent investigations;
- (d) if so, the details thereof including the location-wise details of the said exchanges; and
- (e) the preventive and punitive action taken/being taken by the Government in this regard including ban/closure of such equipments?

(a) & (b) Madam, no incident regarding use of smuggled Sim Box being used by terrorist organizations aiding espionage and facilitating hawala transactions in the country has been reported to Department of Telecom (DoT) during last year 2016 and current year 2017 (upto 28.02.2017).

(c) to (e) Telecom Enforcement Resource and Monitoring (TERM) Cells, the field units of DoT constantly endeavor to curb illegal telephone exchange set ups with the help of law enforcement agencies. A total of 22 number of illegal phone exchanges allegedly operating across the country have been unearthed by TERM Cells during last year 2016 and current year 2017 (upto 28.02.2017). The location-wise details of these illegal phone exchanges and action taken thereon is attached as **Annexure-I**. Equipments used in these illegal set ups are seized by law enforcement agencies and cases are registered against offenders. Further action is taken by the concerned law enforcement agencies.

The modus operandi in most of these unearthed cases is the setting up of an illegal telephone system using high-tech equipments having Leased Line connectivity on one side and Public Switched Telephone Network (PSTN)/Public Land Mobile Network (PLMN) connectivity on the other side. This illegal telephone setup operates in a way that incoming voice calls meant for PSTN/PLMN network are received via the leased link as data traffic (illegal route) thereby by passing the legal International Long Distance Operators (ILDOS) and National Long Distance Operators (NLDOs) route. The PLMN connectivity in these set-ups is mainly provided using mobile SIM Boxes.

Government has issued instructions and guidelines to all licensed service providers for effective monitoring, detection and prevention of such illegal set-ups. Further, in order to curb such illegal activities, all TERM Cells have been regularly sensitized and instructed to create awareness among customers by making them aware of the telecom calls through unauthorized route and bring such calls to the notice of telecom authorities by informing on the Toll Free number 1800110420.
