- (a) whether Government has approved a new scheme with the objective to provide financial assistance/capital subsidy to small powerloom units for installation of Solar Photo Voltaic (SPV) plant in order to alleviate the problem of power cut/ shortage faced by the decentralized powerloom units in the country;
- (b) if so, the details thereof and the details of projects underway and to be undertaken in the next three years;
- (c) whether the Government has provided funds for the development of Textile Parks in the country, including Karnataka; and
- (d) if so, the details of the funds provided for the purpose during each of the last three years and the current year, State-wise?

(a) & (b): Yes, Madam. Under the Solar Energy Scheme, there are two options for the plants; (i) On-Grid Solar Power Plant where power cuts/shortage is negligible and power tariff is high and (ii) Off-Grid Solar Power Plant areas where there is power shortage & on grid power is not continuously available. Financial assistance/capital subsidy to be given under the scheme is as follows:-
