#### 3302. ADV. NARENDRA KESHAV SAWAIKAR:

Will the Minister of Electronics and Information Technology be pleased to state:

- (a) the details of the aims and objectives of the Pradhan Mantri Gramin Digital Saksharta Abhiyan along with the total outlay and funds allocated under this Abhiyan, State-wise;
- (b) whether the Abhiyan will cover the entire rural areas of the country and if not, whether the programme would be extended to the entire rural areas of the country in future; and
- (c) the time frame fixed for implementation of the Abhiyan?

## ANSWER

## MINISTER OF STATE FOR ELECTRONICS AND INFORMATION TECHNOLOGY (SHRI P.P.CHAUDHARY)

(a): The main objective of the "Pradhan Mantri Gramin Digital Saksharta Abhiyan (PMGDISHA)" is to make six crore rural households, across States/UTs, digitally literate, reaching to around 40% of rural households. The total outlay of the Scheme is Rs. 2,351.38 Crore(approx.). It will be implemented as a Central Sector Scheme by the Ministry of Electronics & Information Technology through an implementing agency namely CSC e-Governance Services India Limited, with active collaboration of all the State Governments and UT Administrations. The tentative state-wise funds requirement based on the expenses towards training fee, certification/assessment fee and programme management is at **Annexure**.

(b): The Scheme is applicable for rural areas of the country. To ensure equitable geographical coverage across the country, a Gram Panchayat centric approach would be adopted with targets being assigned and monitored for each of the around 2.50 lakh Gram Panchayats. On an average a target of 200-300 beneficiaries per Gram Panchayat is envisaged. Actual target for the Gram Panchayat would be decided by the District e-Governance Society (DeGS) chaired by the District Magistrate, keeping in view the size of district, population, local requirements, etc.

(c): The PMGDISHA scheme will be completed by 31<sup>st</sup> March 2019.
