Will the Minister of **DRINKING WATER AND SANITATION** be pleased to state:

- (a) the details of the projects received from various States and approved by the Union Government under the Swachh Bharat Mission (SBM) during 2014-15, State-wise;
- (b) the details of the financial assistance provided for the said projects during the said period, State-wise;
- (c) whether funds have been allocated to carry out Solid and Liquid Waste management related works in the villages; and
- (d) if so, the details thereof including the details of the funds released under the said component during the said period, State-wise?

- (a) The Swachh Bharat Mission (Gramin) (SBM(G)) has been launched on 2nd October, 2014, which aims at attaining Swachh Bharat by 2nd October 2019. The focus of the scheme is on behavior change and usage of toilets. Currently, Swachh Bharat Mission (Gramin) is under implementation in 675 districts. The State/UT wise details is at Annexure 1.
- (b) State/UT-wise, central share released under Swachh Bharat Mission (Gramin) during 2014-15 is at Annexure-2.
- (c) Funds for Solid and Liquid Waste Management activities with cap of Rs. 7/12/15/20 lakh are available for Gram Panchayats having upto 150/300/500/ more than 500 households.
- (d) Under Swachh Bharat Mission (Gramin), component-wise funds are not released. However, fund released to State/UT may be utilised for Solid and Liquid Waste Management also.
