Will the Minister of CULTURE be pleased to state:

- (a) whether the Government keeps track of the different Non-Governmental Organisations (NGOs) and Cultural Organisations working in the field of preserving and promoting Indian Heritage, art and culture of various forms;
- (b) if so, the details thereof along with the amount of funds provided to such organizations under the 'Scheme for Financial Assistance to Cultural organizations with National Presence' during the last three years, State/UT-wise and Organisation-wise;
- (c) whether the Government has received or demanded utilization certificate from any of these organizations and if so, the details thereof and if not, the reasons therefor;
- (d) whether the Government has any plan to review and amend the criteria of spending 3 crores in last 5 years to be eligible to get financial assistance under the 'Scheme for Financial Assistance to Cultural Organisations with National Presence' and if so, the details thereof; and
- (e) whether the Government has sanctioned financial assistance to organizations working in the same way but at the State level who are promoting Indian art and culture in smaller volume and if not, the reasons therefor?

(a) & (b) The Government keeps only records (as required under the existing provisions of the schemes) of those grantee organizations working in the field of preserving and promoting Indian Heritage, art and culture of various forms and have been getting financial assistance.

The fund provided to such organizations under the 'Scheme for Financial Assistance to Cultural organizations with National Presence' during the last three years is at Annexure.

(c) The Government receives and demands the utilization certificate from every grantee organization as required under the guidelines of the Schemes.
