Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) whether the University Grants Commission (UGC) provides financial assistance for remedial coaching to under graduates and post graduate students including Scheduled Castes/Scheduled Tribes students, if so, the details thereof;

(b) the number of such students including SC/ST students benefited from the said programmes during the last three years and the current year, State/UT-wise;

(c) whether UGC is offering any scholarship/incentives to the students for such coaching facilities;

(d) if so, the details thereof and if not, the reasons therefor; and

(e) the total amount of grants sanctioned to colleges as well as central and deemed universities during the last three years and current year?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (Dr. MAHENDRA NATH PANDEY)

(a): Yes, Madam. The University Grants Commission (UGC) provides financial assistance to Universities/Colleges under its Remedial Coaching Scheme for Scheduled Caste (SC), Scheduled Tribe (ST) and Other Backward Classes (OBC) (Non creamy layer) and Minority community students.

(b): UGC maintains region-wise and category-wise data on number of student beneficiaries under the Remedial Coaching Scheme. Detailed number of SC/ST students beneficiaries under the scheme in colleges during XIIth Five Year Plan (2012-17) are at Annexure-I.

(c) to (e): The Remedial Coaching Scheme aims at improving and strengthening Under Graduate and Post Graduate students' knowledge base, academic skills and linguistic proficiency. No separate scholarship/incentive is offered to students by UGC under this scheme. Details of grants released to Universities/Colleges by UGC under this scheme during the XIIth Five Year Plan (2012-17) are at Annexure-II.
