ENTITLEMENT FOR WOMEN UNDER NFSA

4192. SHRI C.N. JAYADEVAN:

Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION उपभोक्ता मामले, खाद्य और सार्वजनिक वितरण मंत्री be pleased to state:

(a) whether the National Food Security Act states that at least Rs. 6000 shall be provided to all pregnant and lactating women for which the Government needs to launch a scheme;

(b) if so, the time line by which the Government plans to make this entitlement available to all women in the country;

(c) the budgetary allocation in the current year for this purpose; and

(d) the estimated number of women who would be eligible for this entitlement and the coverage of women during the years 2015-16, 2016-17 and estimated coverage for 2017-18, State-wise?

ANSWER

MINISTER OF STATE FOR CONSUMER AFFAIRS, FOOD & PUBLIC DISTRIBUTION (SHRI C. R. CHAUDHARY)

(a) & (b): The National Food Security Act provides for maternity benefit of not less than Rs. 6000/- to every pregnant woman and lactating mother (PW&LM), except those in regular employment with the Central Government or State Government or Public Sector Undertaking or those in receipt of similar benefits under any law for the time being in force, as per the scheme of the Central Government. The Ministry of Women and Child Development is implementing a centrally sponsored scheme, namely, Maternity Benefit Programme (erstwhile Indira Gandhi Matritva Sahyog Yojana) since 2010 in 53 districts of the country on pilot basis. Under the scheme, maternity benefits of Rs.6,000/- per beneficiary is provided in two equal installments to PW&LM on fulfillment of certain conditions stipulated under the scheme.

The Government of India has approved pan-India implementation of the Maternity Benefit Programme to cover all the districts of the country. The programme envisages payment of Rs.6,000/- to all eligible PW&LM except those in regular employment with the Central Government or State Government or Public Sector Undertaking or those who are in receipt of similar benefits under any law for the time being in force.

(c) There is a budget provision of Rs.400.00 crore for implementation of the Programme during the financial year 2016-17.

(d) The estimated number of beneficiaries with the pan India implementation of the Maternity Benefit Programme is about 51.70 lakh beneficiaries. The beneficiary coverage, as reported by States/UTs, during 2015-16 and 2016-17 under the Programme is at Annexure.
