PROCUREMENT OF FOODGRAINS

4224. SHRI RAHUL KASWAN:

Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION उपभोक्ता मामले, खाद्य और सार्वजनिक वितरण मंत्री be pleased to state:

- (a) the details of the total procurement made by the Food Corporation of India in the country during the last three years, State-wise including Rajasthan;
- (b) whether Private Sector Companies have been allowed to procure foodgrains;
- (c) if so, the names of the private companies engaged in procurement in Rajasthan; and
- (d) the details of the foodgrains along with their prices procured by the said companies during the last three years, State-wise including Rajasthan?

ANSWER

MINISTER OF STATE FOR CONSUMER AFFAIRS, FOOD & PUBLIC DISTRIBUTION (SHRI C. R. CHAUDHARY)

- (a): The total quantum of paddy in terms of rice, wheat and coarsegrains procured by Govt. agencies including Food Corporation of India (FCI) for Central Pool during the last three years State-wise including Rajasthan is enclosed as Annexure-I, II & III respectively.
- (b), (c) & (d): To increase outreach of Minimum Support Price (MSP) operations for paddy in eastern states of the country, private players have been engaged in paddy/rice procurement at MSP in Uttar Pradesh, Jharkhand & West Bengal.

No private player has been engaged for procurement operation in Rajasthan and no procurement has been done through private players in the State of Rajasthan during last three years.

Total procurement of rice by private players at MSP during Kharif Marketing Season (KMS) 2013-14 to KMS 2015-16 is as under:-
