The objective of the scheme is to generate self employment and provide infrastructure for dairy sector.
- (d) There is no provision of skill development training under “Dairy Entrepreneurship Development Scheme (DEDS)”. However, under DEDS, as on 28.02.2017, 265478 dairy units were approved and Rs 103503.29 lakh subsidy disbursed.
