- (c) whether the funds allocated have been utilized properly and if so, the details thereof and if not, the action taken by the Government in this regard;
- (d) Whether the Government proposes to constitute an independent agency to ensure fair evaluation of Government run programmes so that the benefits of public sector schemes reach to targeted people; and
- (e) if so, the details thereof along with the term of reference of the Agency?

- (a.) Yes, Madam. During the period of last three years i.e. 2013-14 to 2015-16, the Development Monitoring and Evaluation Office (erstwhile Programme Evaluation Organization)has carried out evaluation of 12 programmes.
- (b) & (c) Out of the 12 programmes evaluated during 2013-14 to 2015-16, the required information has been tabulated for eight major programmes as per Annexure-I.
- (d) & (e) The Government of India had established the Development Monitoring and Evaluation Office on 18th September, 2015 as an attached office of the NITI Aayog by merging the erstwhile Programme Evaluation Organization and Independent Evaluation Office. The main mandate of the Development Monitoring and Evaluation Office is to monitor and evaluate the Central Government funded programmes and initiatives. The Development Monitoring and Evaluation Office has been provided full functional autonomy in addition to its own budgetary and manpower resources. No. A-11016/1/2014-Admn.1: In pursuance of the approval of the Competent Authority, the Development Monitoring and Evaluation Office (DMEO) is hereby constituted by merging the programme Evaluation Organization (PEO) and the Independent Evaluation Office (IEO), and notified as an attached Office under the aegis of NITI Aayog for fulfilling the mandate of Evaluation and Monitoring assigned to NITI Aayog.

- 2. The officers and employees holding office under the erstwhile PEO and IEO immediately before the date of constitution of DMEO shall continue to hold office of DMEO by the same tenure and upon the same terms and conditions of service; and continue, as such, until further orders.
- 3. On and from the 18th day of September, 2016, all asses5s kand budget of the PEO and IEO, shall be transferred to and shall vest in the DMEO. The assests and budgets shall include rights, powers, authorities and all property movable and immovable including cash balances, any fund available and all other rights and interest in such assets and property as were, immediately before the said date in the ownership, possession, power and control of the PEO and IEO.
- 4. The DMEO shall be the successor in interest of the PEO and IEO.
- 5. Further, out of the posts transferred from IEO to DMEO, the post of Director General (in the rank and Status of Member, Planning Commission) shall be operated as Director General, DMEO at the level of Additional Secretary and four posts of Director (HAG Scale) stands redesignated as Deputy Director General, DMEO at the level of Joint Secretary.
