- (a) the details and the present status of development of Coastal Economic Zones (CEZs) along the coastlines of the country, project-wise;
- (b) whether many State Governments have expressed their interest to participate and contribute in the development of these CEZs;
- (c) if so, the details thereof;
- (d) whether the Government propose to put special emphasis on the development of CEZ along the long coastline of Gujarat particularly in view of the Act East Policy of India; and
- (e) if so, the details thereof?

(a): Details of Fourteen (14) Coastal Economic Zones (CEZs) identified for development under National Perspective Plan of Sagarmala Programme (2016-2035) is given in Table below:

(a)&(c): The Perspective Plans for the CEZs have been finalized in consultation with related State Governments and Ministries of Union Government. Based on the response regarding land details from the States, the process for preparation of Detailed Master Plans for CEZ's in Andhra Pradesh and Gujarat in the initial phase, have been initiated. The respective State Governments have been requested to furnish land details for the CEZs identified in those states.

(d)&(e): Out of the 14 identified CEZs, 3 are in the State of Gujarat. Out of these three, CEZ linked with Kandla Major Port and Mundra Port has been prioritized for master planning.
