(a): The State wise details of number of persons affected by leprosy in the country including the State of Chhattisgarh is **annexed.**

(b) & (c): The National Leprosy Eradication Programme has been reviewed at different levels twice including each at the level of Minister of Health & Family Welfare and Secretary (Health & Family Welfare). Besides, annual conference for State Leprosy Officers is conducted in collaboration with WHO for reviewing the programme. The programme is also reviewed when officials visit States.
