SETTING UP OF AIIMS LIKE INSTITUTIONS

5015. DR. RAMESH POKHRIYAL "NISHANK": SHRI SUNIL KUMAR MONDAL: SHRI JANAK RAM: SHRI HARI MANJHI:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the details of present and proposed AIIMS like institutions across the country and the time by which such proposed institutions are likely to be functional;
- (b) the States/UTs which have sent proposals for setting up of new AIIMS like institutions in the country;
- (c) the details of funds allocated for the same, State/UT-wise; and
- (d) the criterion laid down for the approval and financial assistance provided by the Government for setting up of such institutions in different parts of the country?

ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI FAGGAN SINGH KULASTE)

(a): Six newly established AIIMSs at Patna (Bihar), Raipur (Chhattisgarh), Bhopal (Madhya Pradesh), Bhubaneshwar (Odisha), Jodhpur (Rajasthan) and Rishikesh (Uttarakhand) have already been made functional. Details can be seen at Annexure-I.

An AIIMS at Rae Bareli is being set up under Phase-II of PMSSY. Thirteen more AIIMS have been announced to be set up in different states. Out of which, Cabinet has approved setting up of AIIMS in Andhra Pradesh, West Bengal, Maharashtra, Punjab and Gorakhpur in UP. Details can be seen at Annexure-II.

- (b): Proposals have been received from 17 States for setting up of new AIIMS like institutions. The details are enclosed in Annexure III
- (c): As per Annexure-I & II.
- (d): New AIIMS are announced in Budget speeches and are fully funded by the Central Government.
