- (a) & (b):** The Government reviews FDI policy on an ongoing basis and significant changes are made in the FDI policy regime, from time to time, to ensure that India remains increasingly attractive and investor-friendly investment destination. Further, no proposal is under consideration of the Government to review the extant FDI policy to bring public sectors under its ambit in the country.
- (c):** The sector-wise information on Foreign Direct Investment is available only for equity inflows and relevant details are at **Annexure**.
