Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

- (a) whether the Government has started skill development courses in the entire country;
- (b) if so, the details thereof;
- (c) the details of the skill development courses started by the Government during the last three years, State-wise, including Chhattisgarh;
- (d) the number of unemployed who got employment through this initiative so far; and
- (e) the business-wise details of the companies where these people have been engaged?

(a) to (e) Ministry is implementing its flagship schemes known as Pradhan Mantri Kaushal Vikas Yojana (PMKVY) on pan –India basis to cover the prospective youths. PMKVY enables large number of prospective youths for taking short term fresh training and Recognition of Prior Learning (RPL) through accredited and affiliated training partner/training centers. The schemes runs across 221 job roles related to 35 Sector Skill Councils for short term training and special project. Under PMKVY, 21,84,770 candidates have been trained throughout the county. Under PMKVY 2015-16, it was not mandatory for NSDC's training partners to report employment data. However, as per the reported data, 2.47 laks number of candidates have been given the placement offer.

Further, in domain of long term skill programme, at present there are a total of 13353 ITIs (Govt-2152 & Private-11201) imparting training in the 126 trades (Engineering-73+Non-Engineering-48+ For Divyang-05). The revision of curricula of trades including addition of new trades & deletion is a continuous process based upon the need of the industry & feedback of stakeholders. Also, under the Dual System of Training the top ten popular Craftsmen Training Scheme (CTS) trades are Electrician, Fitter, Machinist, Turner, Electronics Mechanic, Welder, Mechanic Diesel, Mechanic (Motor Vehicle), Cosmetology and Tool & Die Maker (Dies & Moulds). Under Flexi MoU policy, courses are designed according to the specific needs of the industry. Industries are allowed for conducting training programme in higher employment potential courses. The Trainees passing out from the ITIs either go in Apprenticeship training (i.e on the job training) / regular jobs or self-employment. Data of their employment is not maintained by the Directorate General of Training, Ministry of Skill Development and Entrepreneurship.
