#### **Progress under Drinking Water Schemes**

#### **5328. SHRI ANOOPMISHRA:**

Will the Minister of DRINKING WATER AND SANITATION be pleased to state:

- (a) the status and the progress of ongoing schemes being implemented under drinking water schemes in Madhya Pradesh;
- (b) the extent of works completed in percentage for ongoing projects under such scheme in Madhya Pradesh along with the estimated time frame for completion; and
- (c) the funds allocated/released and utilized under drinking water schemes during each of the last three years and the current year in Madhya Pradesh?

#### ANSWER

## MINISTER OF STATE FOR DRINKING WATER AND SANITATION (SHRI RAMESH CHANDAPPA JIGAJINAGI)

(a)& (b)Rural drinking water supply is a state subject. This Ministry under National Rural Drinking Water Programme (NRDWP) supplements the efforts of State Government by giving them technical & financial assistance for improving coverage of safe drinking water in rural areas. State Governments are empowered to plan, design, sanction and execute rural drinking water schemes. The schemes to be taken up in a State are approved by the State Level Scheme Sanctioning Committee (SLSSC). The responsibility of setting time frame for execution and completion of a scheme completely lies with the respective State Government.

As per data entered by State Government of Madhya Pradesh on the Integrated Management Information System (IMIS) of this Ministry, details of ongoing schemes under NRDWP and the extent of works completed / at various stages of completion in percentage, as on 02.04.2017, is as under:
