SETTING UP OF BIOGAS PLANTS

5346. SHRI JUGAL KISHORE:

Will the Minister of NEW & RENEWABLE ENERGY be pleased to state:

- (a) the target fixed and achievements made for setting up of bio-gas plants under the National Biogas and Manure Management Programme (NBMMP) in the country during the current Five Year Plan;
- (b) whether some State Governments are facing difficulties due to paucity of funds in setting up of these plants and if so, the details thereof;
- (c) whether some State Governments including the Government of Jammu & Kashmir have sent proposals to provide funds for this purpose;
- (d) if so, the details thereof, State-wise; and
- (e) the steps taken or likely to be taken by the Union Government in this regard, State-wise?

ANSWER

THE MINISTER OF STATE FOR POWER, COAL, NEW & RENEWABLE ENERGY AND MINES (INDEPENDENT CHARGE) (SHRI PIYUSH GOYAL)

(a): The year-wise targets and achievements under the National Biogas and Manure Management Programme (NBMMP) are given below -

(b): The Government is providing Central Financial Assistance (CFA) to the State Governments under the NBMMP. The details of funds released to the States during the year, 2016-17 are given at **Annexure-I**.

(c) to (e): The Ministry of New & Renewable Energy (MNRE) calls proposals from the States for allocation of annual targets under the NBMMP at the beginning of the year. On the basis of the previous performance, the annual targets are fixed and communicated to the States, which is followed by release of first installment of funds. The details of the physical and financial targets allocated to the States, including Government of Jammu & Kashmir, for the purpose of setting up of biogas plants under the NBMMP during the year 2016-17 is given at **Annexure-II**.
