Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) the details of expenditure incurred by the Government on establishing vocation/professional institutions with the help of Non-Governmental Organisations (NGOs) in the country during the last three years as on date, scheme-wise and State-wise; and
- (b) the number of above institutions functioning in the country, scheme-wise and State-wise during the said period?

- (a) & (b): A total number of 271 Jan Shikshan Sansthans (JSS) and 33 State Resource Centres (SRC) were established upto 11th Plan Period under the aegis of Non-Governmental Organisations (NGOs) out of which 250 JSSs and 32 SRCs are functional. However no vocation / professional institution with the help of NGOs has been established during the last three years under the Scheme of Support to Voluntary Agencies for Adult Education and Skill Development. The details of the expenditure incurred in the last three years, on imparting vocation / professional training with the help of NGOs in the country and the Scheme-wise / State-wise details of NGOs functioning in the country is at **Annexure**.
