ANSWER MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI RAM KRIPAL YADAV)

- (a): State-wise details of funds allocated, released and expenditure incurred under the National Social Assistance Programme(NSAP) during the last two years is at **Annexure**.
- (b) to (d): The task related to identification of beneficiaries, sanction and disbursement of benefit under National Social Assistance Programme Programme (NSAP) is left with the States/UTs. The grievances and requests received through Centralized Public Grievance Redress and Monitoring System(CPGRAMS) as well as physically, in respect of implementation of schemes under NSAP, are forwarded to the concerned State/UTs for appropriate action.

The implementation of the schemes under NSAP is reviewed through periodic Performance Review Committee (PRC) and Nodal Officers Meetings. Schemes are also monitored by National Level Monitors(NLMs) and through Area Officers Visits.
