- (a) whether Regional Ayurveda Research Institute for Life Style Related Disorders (RARILSRD) is functioning in Kerala;
- (b) if so, the details thereof along with its objectives and salient features;
- (c) whether RARILSRD, Kerala is facing a lot of stumbling blocks including the shortage of fund and facilities:
- (d) if so, the details thereof and corrective measures taken by the Government in this regard; and
- (e) whether the Government has received any representation in this regard and if so, the details thereof and the response of the Government thereto?

## **ANSWER**

# THE MINISTER OF STATE (IC) OF THE MINISTRY OF AYURVEDA, YOGA & NATUROPATHY, UNANI, SIDDHA AND HOMOEOPATHY (SHRI SHRIPAD YESSO NAIK)

(a) & (b): Yes. Ministry of AYUSH has set-up an autonomous Research Council, namely, Central Council for Research in Ayurvedic Sciences (CCRAS) as apex body for formulation, coordination, development and promotion of research activities in Ayurvedic medicine system for various diseases. Regional Ayurveda Research Institute for Life Style Related Disorders (RARILSRD) is functioning under CCRAS at Thiruvananthapuram, Kerala.

The mandate of RARILSRD is as under:-

- Clinical Research focusing on Life style related Disorders.
- Other Activities:
  - ➤ Health care services through Out–Patient Department (OPD)
  - > Special Clinics for Geriatric Health Care
  - > Outreach Activities such as Swasthya rakshan Programme etc.
