**CHEAP STEEL IMPORTS**

Will the Minister of STEEL be pleased to state:

- (a) whether the Government has brought or proposes to bring more steel grades *i.e.* cold reduced low carbon sheets and strips, hard drawn wire and cold rolled strips under the quality control order, if so, the details thereof;
- (b) whether the Government has imposed 57 per cent anti-dumping duty on the steel imports to provide relief to the domestic steel industry, if so, the details thereof;
- (c) whether the Government has imposed different amount of anti-dumping duty on the steel imports from the different countries including China and Thailand, if so, the details thereof and the reasons therefor, country-wise; and
- (d) the other steps being taken by the Government to protect and promote the domestic steel industry?

**ANSWER**

THE MINISTER OF STATE FOR STEEL

- (a) Ministry of Steel has brought cold reduced low carbon sheets and strips and cold rolled strips under the quality control order vide order dated 18<sup>th</sup> December 2015.
- (b) The Government had notified anti-dumping duty vide Notification No. 61/2015-Customs (ADD) on imports of Cold Rolled Stainless Steel Flat products. The duty rates vary from 4.58% to 57.39% depending on the country and producer.
- (c) There are different rates of duty applicable to different countries. The duty rates vary from 4.58% applicable on exports from Thailand to 57.39% on any exports from China. The detailed duty structure is provided in **Annexure-I**.
- (d) In order to protect and promote the domestic steel industry the Government has taken following measures:-
  - Increased the peak rate of basic customs duty on both flat and non-flat steel to 15% from 10%.
  - Increased the import duty on flat rolled steel @ 10% on long and semi finished products.
  - Levied the Anti-Dumping Duty on imports of certain variety of hot-rolled flat products of stainless steel from China.
  - Levied the Anti-Dumping Duty for five years on imports of cold rolled Flat products of stainless steel.
  - Government has notified Minimum Import Price (MIP) to provide a level playing field to domestic producers against the injury caused as evident from the decline in margins of the producers.
  - Imposed the Safeguard Duty of 20% on hot-rolled flat products of non-alloy and other alloy steel, in coils.
