#### **Functioning of PSUs without Head**

#### 6012. SHRI B. SRIRAMULU:

Will the Minister of HEAVY INDUSTRIES AND PUBLIC ENTERPRISES be pleased to state:

- (a) whether a large number of Public Sector Undertakings (PSUs) are functioning without Heads/CMD/Chairman at present and if so, the details thereof, PSU-wise;
- (b) the time by which the said appointments are likely to be made;
- (c) whether it is a fact that Chairman/CMD /Directors of Schedule 'C' PSUs companies are getting pay scales of Schedule 'B' PSUs, if so, the details thereof and the reasons therefor:
- (d) whether the upgradation of pay scale has been ratified by the appointment Committee of the Cabinet; and
- (e) if so, the details thereof?

#### ANSWER

### THE MINISTER OF STATE FOR HEAVY INDUSTRIES AND PUBLIC ENTERPRISES (SHRI BABUL SUPRIYO)

- (a): As per available information, there are 42 Central Public Sector Enterprises (CPSEs) which presently do not have a regular Managing Director/Chairman & Managing Director (CMD)/Chairman. The list of these 42 CPSEs is annexed.
- (b): The filling up of Board level posts in CPSEs is a continuous process and these 42 vacant posts would get filled in due course after completion of necessary formalities.
- (c) to (e): The Government has laid down guidelines for upgradation of Board level posts of CPSEs on a personal basis which provides for grant of higher schedule of pay to the concerned Board level incumbent.

There are no cases which have been approved by the Appointments Committee of the Cabinet where Chairman/CMD/Directors of Schedule 'C' CPSEs are getting pay scales of Schedule 'B' CPSEs.
