POS DEVICES IN FAIR PRICE SHOPS

6046. SHRI ANTO ANTONY: SHRI RAM MOHAN NAIDU KINJARAPU:

Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION उपभोक्ता मामले, खाद्य और सार्वजनिक वितरण मंत्री be pleased to state:

(a) whether the Government proposes to install Point of Sale (PoS) devices in Fair Price Shops (FPS), if so, the details thereof;

(b) the total number of fair price shops in each State including Andhra Pradesh;

(c) the number of FCI storehouses in each State including Andhra Pradesh; and

(d) whether the Government plans to set up more fair price shops and FCI centres in the country in the coming years and if so, the details thereof?

ANSWER

MINISTER OF STATE FOR CONSUMER AFFAIRS, FOOD & PUBLIC DISTRIBUTION (SHRI C. R. CHAUDHARY)

(a) & (b): This Department has prepared guidelines for Fair Price Shop (FPS) automation, which have been shared with all States/UTs. FPS automation involves, installation of Point of Sale (PoS) devices at FPS for authentication of beneficiaries, recording of sales to beneficiaries at the FPS; and uploading of transaction data in central server. There are 5.26 lakh Fair Price Shops in the country out of which 1.86 lakh FPSs have been automated so far installing ePoS devices/mobile terminals across 22 States/UTs. A statement showing the total number of FPSs in each States/UTs including Andhra Pradesh and automation of FPSs is given at Annexure-I.

(c): The total no. of Godowns with FCI (as on 28.02.2017) are 1784 (Owned – 540, Hired – 1244). The State-wise detail including Andhra Pradesh is given at Annexure-II.

(d): Targeted Public Distribution System (TPDS) is operated under the joint responsibility of the Central and State/UT Governments wherein operational responsibilities including the issuance of licenses to the Fair Price Shops (FPSs) rest with the concerned State/UT Governments. As regards setting up of more FCI centers, sufficient storage facilities are available for storage of central pool foodgrains stock. The storage capacity available with FCI and State agencies for storage of central pool stock is 776.25 Lakh MT (Covered - 626.08 Lakh MT and CAP - 150.17 Lakh MT) against the stock of 298.36 Lakh MT as on 28.02.2017. However, the following steps are being taken by Government in order to augment covered storage capacity in the country for strengthening foodgrain storage system:-

(i) Government of India has formulated a scheme called Private Entrepreneurs Guarantee (PEG) Scheme for construction of covered storage capacity. Under this Scheme, storage capacity is created by private parties, CWC, SWCs and other State Agencies for guaranteed hiring by FCI. Under PEG scheme, a capacity of 150.89 lakh MT has been sanctioned/ allotted to private investors, CWC and SWCs. A capacity of 136.03 lakh MT has already been completed as on 28.02.2017.

(ii) In addition, Under 12th Five Year Plan, Government has approved augmentation of storage capacity by 2,92,730 MT in the States of North Eastern Region and by 76,220 MT in States other than North East. As on 28th February, 2017 a total capacity of 1,37,680 MT capacity has been completed.

(iii) Government has approved action plan for construction of steel silos in the country to the tune of 100 Lakh MT in the next four years in 3 phases, as per details below:
