6112. SHRIMATI HEMA MALINI:

Will the Minister of SOCIAL JUSTICE AND EMPOWERMENT be pleased to state:

- (a) whether the Government has launched/proposes to launch any scheme for upliftment and development of women belonging to SC/OBC community;
- (b) if so, the details and objectives of the said scheme along with the quantum of funds allocated by the Government thereunder; and
- (c) the number of women benefited so far during each of the last three years and the current year, State-wise, particularly in Punjab?

(a) to (c): The Ministry of Social Justice and Empowerment, Government of India, implements several schemes for upliftment and development of women belonging to Scheduled Castes(SC) and Other Backward Classes(OBC) which, inter-alia, include the following:

- i. Babu Jagjivan Ram Chhatrawas Yojana for Girls under which hostels are constructed for SC girls;
- ii. Construction of Hostels for OBC Boys and Girls under which hostels are constructed for OBC girls.
- iii. Schemes of National Scheduled Castes Finance & Development Corporation and the National Backward Classes Finance & Development Corporation which provide loans for eligible SC and OBC women beneficiaries at concessional rates respectively to set up entrepreneurial projects.
- iv. Scholarships are given to SC and OBC student beneficiaries which are availed by eligible girl/women beneficiaries also. However data is not separately maintained for boys and girl/women beneficiaries.

Details of beneficiaries for the years 2014-15, 2015-16 & 2016-17 and allocation of funds for the year 2017-18 in respect of schemes at i, ii and iii above are given in Annexure I to IV.
