FREE/CHEAPER SERVICES BY BSNL

6299. SHRI A. ARUNMOZHITHEVAN:

Will the Minister of COMMUNICATIONS be pleased to state:

- (a) whether the BSNL proposes to provide free voice calling on its network and if so, the details thereof;
- (b) whether the BSNL proposes to offer plans/tariff cheaper than tariffs offered by private players and if so, the details thereof and if not, the reasons therefor; and
- (c) whether the BSNL runs the risks of incurring losses in the event of providing free/cheap services and if so, the details thereof and the steps taken by the Government to cover the aid risks?

ANSWER

THE MINISTER OF STATE (IC) OF THE MINISTRY OF COMMUNICATIONS & MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI MANOJ SINHA)

- (a) No Madam. However, Bharat Sanchar Nigam Limited (BSNL) offers unlimited voice calls on its own mobile and landline network under various plans. Details are at **Annexure**.
- (b) BSNL reviews its tariff from time to time based on market conditions and the tariff offered by BSNL is competitive in comparison to other private operators.
- (c) There is a severe and cut throat competition in the market since last few months leading to lowering of tariff by different telecom service providers. BSNL also matched the offers by lowering its tariff, consequently BSNL runs the risk of incurring losses. However, BSNL has taken following steps to maintain and increase its revenue:
 - i) Mobile equipment is being procured and upgraded progressively for capacity augmentation of BSNL's network and improvement of services.
 - ii) BSNL is upgrading its landline network with Next Generation Network (NGN) and augmenting the capacity of the Broadband Core Network for improvement of landline and broadband services.
 - iii) WiFi hotspots are progressively rolled out to enable customers to avail high speed internet over mobile devices.
 - iv) Competitive tariff is offered to its customers keeping in view the existing market conditions.

I. Mobile Services

a. <u>Post-paid Mobile Services</u>: Under Plan 725, BSNL is offering unlimited local calls on own network. Under Plan 799, Plan 1125 and Plan 1525, BSNL is offering unlimited local and Subscriber Trunk Dialling (STD) calls to any network, together with different quantity of data usage. Moreover, Plan 799 is being offered with the Fixed Monthly Charges of Rs. 599 for the first four months.

b. Prepaid Mobile Services:

BSNL is also offering unlimited calls under the following prepaid plans.

Customers have the option to continue the facility beyond the initial period by using Special Tariff Voucher(STV) @142/-. With the STV, customers can avail unlimited voice calls on own network and upto 20 minutes per day to any other network for a period of 30 days.

STV with Unlimited Voice Calling facilities are offered to all the Prepaid Mobile Consumers across its service area

II. Landline Services

- **a.** BSNL offers unlimited free calls to any network between 9 PM to 7 AM on all days and unlimited free calls to any network throughout Sundays to all its landline customers.
- **b.** BSNL is also offering unlimited broadband services @ Rs 249/- per month for initial period of six months.
