**Education Level of Girls**

**6378. SHRI NISHIKANT DUBEY:**

Will the Minister of **MINORITY AFFAIRS** be pleased to state:

- (a) whether the education level in minority girls in the country is not satisfactory;
- (b) if so, the details thereof and the reasons therefor;
- (c) the details of schemes implemented by the Government to promote education amongst minority girls and women in the country, especially in the rural areas; and
- (d) the details of fund allocated/utilized during each of the last three years to promote education amongst minority girls and women in the country, State-wise including Jharkhand?

(a) & (b): As per the available segregated data based on Census 2001 and 2011, the literacy rate among the girls in the country indicates varying female literacy rates and improvement among various minority communities/categories as follows:-

<b>Communities / Categories</b>	<b>Female Literacy Rate (%)</b>	
	<b>2001</b>	<b>2011</b>
Muslim	50.1	62.0
Christian	76.2	81.5
Sikh	63.1	70.3
Buddhist	61.7	74.0
Jain	90.6	92.9
Other Religions and Persuasions*	33.2	49.1

\*The Parsis are included among 'Other Religions and Persuasions'.

The national data of female literacy rate is as below:-

1. 53.7% as per Census 2001.
2. 64.6% as per Census 2011.

(c): This Ministry implements the following schemes for educational empowerment of the six notified minorities, namely, Muslims, Christians, Sikhs, Buddhists, Parsis and Jains, including minority girls and women throughout the country, including the rural areas:-

- (1) Pre-Matric Scholarship Scheme
- (2) Post-Matric Scholarship Scheme
- (3) Merit-cum-Means based Scholarship Scheme
- (4) Maulana Azad National Fellowship for minority
- (5) Free coaching and allied Scheme
- (6) “PadhoPardesh”– Scheme of Interest Subsidy on Educational Loans for Overseas Studies for the Students belonging to the Minority Communities
- (7) Support for students clearing Prelims conducted by UPSC, SSC, State Public Service Commission (PSC) etc. (NaiUdaan).

At least, 30% of scholarships are earmarked for girl students under the schemes at serial No.(1) to (5). In addition, an exclusive scholarship scheme for minority girls studying in class XI and XII, namely, Begum Hazrat Mahal National Scholarship for Meritorious Girls belonging to minorities, is implemented through Maulana Azad Education Foundation (MAEF), an autonomous body under this Ministry.
