EMPLOYMENT AND VOCATIONAL TRAINING TO SURRENDERED MAOISTS

Will the Minister of HOME AFFAIRS be pleased to state:

(a) the number of Maoists surrendered including those who surrender with arms along with the types and sources of arms they have surrendered during each of the last three years and the current year, State-wise;

(b) whether a large number of surrendered Maoists are still staying in their villages;

(c) if so, the protective measures taken by the Government as they are the soft targets;

(d) the number of surrendered Maoists provided gainful employment and vocational training along with the monthly stipend during the said period; and

(e) the number of surrendered Maoists who have withdrawn their grants after 3 years of good behaviour and the amount of funds utilised under the Civic Action Programme (CAP)?

(a) and (b):Details of Left Wing Extremists surrendered during the last three years and the current year (as on 15.01.2017), State wise is at Annexure. The numbers of LWE cadres surrendered with arms along with

types and sources of arms surrendered and figures pertaining to whether large numbers of surrenderees are staying in village are not maintained Centrally.

(c): Surrender and Rehabilitation policy is implemented by the concerned States as Police and Public Order are State subjects. The District Officers provides immediate security to the surrenderees.

(d) & (e): Figures regarding employment & withdrawal of grant are not maintained at Government of India level. The year wise details of funds utilised/ released by LWE affected States under the Civic Action Program during last three years and the current year 2016-17 (as on 31.01.2017) is at Annexure.
