PROF. RAVINDRA VISHWANATH GAIKWAD:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

(a) the present status of National Rural Health Mission (NRHM) in the country and its achievements in each of the last three years and the current year;

(b) the condition of primary health centres in rural areas in the absence of trained doctors or staff posted there and lack of availability of medicine and if so, the details thereof;

(c) whether the Government has made any assessment of progress in providing public health infrastructure after launching the NRHM and if so, the details thereof, State/UT-wise including Rajasthan;

(d) whether the Government is aware that there is an acute shortage of basic facilities in rural areas of the country and if so, the details thereof, State/UT-wise; and

(e) the steps taken by the Government for making available better health services in the Government hospitals of rural areas?

STATEMENT REFERRED TO IN REPLY TO LOK SABHA
STARRED QUESTION NO. 190* FOR 28TH JULY, 2017

(a) National Rural Health Mission (NRHM) is now a sub-Mission under the overarching National Health Mission (NHM), along with National Urban Health Mission (NUHM) as the other sub-Mission. It is implemented in all the States/UTs in the country. The Achievements for NHM are given at **Annexure-I**.

(b) The status of availability of Primary Health Centres (PHCs) in rural areas is at **Annexure – II**. Status of availability of doctors and other staff at PHCs is at **Annexure-III**. Public health and hospitals being a State subject, the primary responsibility to ensure availability of trained doctors, staff and medicine in public health facilities lies with the respective State/UT Governments. Currently, information about availability of medicines at PHCs is not maintained centrally. However, all States have notified Free Drug Policy for public health facilities.

(c) As per Rural Health Statistics (RHS) 2016, the health care infrastructure has increased after launch of NRHM in April 2005. The number of public health facilities in rural areas State/UT-wise including Rajasthan during 2005 and 2016 is at **Annexure -IV**.

(d) Status of infrastructure and basic health facilities in public health centres in rural areas is at **Annexure-V**.

(e) Public health and hospitals being a State subject, the primary responsibility to provide healthcare services to its people lies with the respective State/UT Governments. However, under the National Health Mission (NHM), financial and technical support is provided to States/UTs to strengthen their healthcare systems.

Details about some of the key steps taken to improve health services in government hospitals in rural areas is at **Annexure-VI**.

Achievements for NHM during last three years

Sample Registration System (SRS) which provides information in respect of Infant Mortality Rate (IMR), Maternal Mortality Ratio (MMR) and Total Fertility Rate (TFR) is available only upto 2015.

- IMR has reduced from 42 in 2012 to 40 in 2013, 39 in 2014 and 37 in 2015 (SRS).
- MMR has reduced from 178 in 2010-12 to 167 in 2011-13 (SRS).
- TFR has reduced from 2.4 in 2012 to 2.3 during the period 2013 to 2015 (SRS).
- In respect of Tuberculosis (TB), the incidence of TB reduced from 234/ lakh population in 2012 to 228/ lakh population in 2013 to 223/ lakh population in 2014 and to 217/ lakh population in 2015. Mortality also reduced to from 38/ lakh population during 2012 and 2013 to 37/ lakh population in 2014 and to 36/ lakh population in 2015.
- In respect of Leprosy, the Prevalence rate of Leprosy reduced to less than 1/10000 population in 542 districts in 2014, 532 districts in 2015, 551 districts in 2016, which increased to 556 Districts in 2017.
- In respect of Malaria, the Annual Malaria Incidence was 0.89 in 2014-15, 0.92 in 2015-16, 0.85 in 2016-17 and 0.21 in 2017-18 (upto May'17).
- In respect of Microfilaria, nationally, the Mf rate was 0.43% in 2012, 0.30% in 2013, 0.44% in 2014 which reduced to 0.26% in 2015.
- In respect of Kala Azar, 454 blocks had achieved elimination till 2014. This increased to 492 blocks till 2016.

Steps taken by the Government for making available better health services in the Government hospitals of rural areas

Under NHM Technical and Financial support is provided for strengthening the healthcare systems in States/UTs. The support is provided in various fields, including:

- **Reproductive, Maternal, Newborn, Child and Adolescent Health Services**- It is a Continuum of care approach across all the life stages has been adopted under NHM with the articulation of 'Strategic approach to Reproductive Maternal, Newborn, Child and Adolescent health (RMNCH+A) in India. It includes support towards services for maternal health, child health, family planning, Adolescent Health, Universal Immunisation, initiatives like the Janani Shishu Suraksha Karyakram (JSSK), Rashtriya Bal Swasthya Karyakram (RBSK), Rashtriya Kishor Swasthya Karyakram (RKSK), Mother's Absolute Affection (MAA), Pradhan Mantri Surakshit Matritva Abhiyan (PMSMA) etc.
- **Health System Strengthening under NRHM and NUHM** – Apart from the support for strengthening healthcare systems in rural; areas under NUHM, the NUHM was launched in 2013 to cater to the health care needs of urban population, particularly the poor and vulnerable sections amongst them under the over-arching umbrella of NHM. Health systems strengthening support includes support for augmentation of public health infrastructure, health human resource and programme management personnel, ambulance services e.g. Dial 108 and Dial 102, Mobile Medical Units, community participation including engagement of ASHAs, involvement of Rogi Kalyan Samitis, mainstreaming of AYUSH and provision of drugs and equipment etc. Under this, support is provided for various initiatives like the NHM Free Drugs and Free Diagnostics Service Initiatives, PM National Dialysis Programme, National Quality Assurance Framework, Kayakalp Awards, Swachha Swasth Sarvatra, tele-medicine services, Bio Medical Equipment Management Programme etc.
- **Control of Communicable Diseases** - Under this component, support is provided for various interventions and activities for prevention and control of communicable diseases like Tuberculosis, Leprosy and Vector Borne Diseases like Malaria, Kalazar and Dengue etc.
- **Control of Non-Communicable diseases**: To address the emerging challenge of growing disease burden of Non Communicable Diseases (NCD), all interventions for non-

communicable disease programmes up to District Hospital level and below are supported under NHM through the NCD flexi-pool. These include support towards National Programmes for Prevention and Control of Cancer, Diabetes, Cardiovascular Diseases and Stroke (NPCDCS), National Programme for the Prevention and Control of Deafness (NPPCD), National Oral Health Programme (NOHP), National Programme for Control of Blindness (NPCB), National Mental Health Programme (NMHP), National Tobacco Control Programme (NTCP), National Programme for the Healthcare of the Elderly (NPHCE).

- **Infrastructure Maintenance:** Under this component of NHM, support is provided to States to meet the requirement of salaries of Auxiliary Nurse Midwives (ANMs) and the Lady Health Visitors (LHVs), Urban Family Welfare Centres, ANM/LHV Training Schools, Health & Family Welfare Training Centers, and Training of Multi-Purpose Workers (Male).
