(a) to (c):During the 12th Plan, the Ministry launched a Centrally Sponsored Scheme - National Mission on Food Processing (NMFP) w.e.f. 1.4.2012, which was implemented through State/UT Governments. The basic objective of NMFP was decentralization of implementation of Ministry's schemes with substantial participation of State/ UT Governments.

However, Government of India (GOI) has de-linked Centrally Sponsored Scheme – National Mission on Food Processing (NMFP) from Central Govt. support w.e.f. 01.04.2015 in view of increased resource allocation to States resulting from the recommendations of the 14^{th} Finance Commission. The Statewise position of funds released by the Ministry under NMFP during the last three years is at **Annexure - I**
