†1081. DR. VIRENDRA KUMAR:

Will the Minister of FINANCE be pleased to state:

- (a) the details of foreign banks operating in India;
- (b) the details of the profit earned by the said banks during the last three years and the current year, Bank-wise;
- (c) the percentage of profit sharing between the parent country of the bank concerned and India Bank-wise; and
- (d) the role of the Reserve Bank of India in regulating the operations of the said banks?

(a) to (d): The details of foreign banks operating in India, Net Profit / Loss of Foreign Banks and Appropriations – Remittance to Head Office & Appropriations – Remittance to Head Office as percentage of Net Profit/Loss for FY 2014-15, 2015-16 & 2016-17 (Prov.), furnished by Reserve Bank of India (RBI) are given in the Annexure. Foreign Banks are also regulated / supervised by RBI like other commercial banks.
