Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) whether the Government has received any representation regarding release of funds to Model Schools in the various States of the country including Telangana;
- (b) if so, the details thereof, State/UT-wise; and
- (c) the details of quantum of funds earmarked and released so far State/UT-wise?

(a) & (b) : Yes, Madam. Representations have been received from States of Jharkhand, Chhattishgarh, Tamil Nadu, Telengana, Karnataka, Tripura and Andhra Pradesh for release of funds for Model Schools. However, the Model School Scheme was delinked from support of Government of India and stands transferred to State sector with effect from 01.04.2015 in the light of enhanced devolution of financial resources to the States as per the recommendation of 14th Finance Commission. It has been expected that States would be able to address their state specific needs through flexibility in design and implementation of the scheme from the state resources.

(c) : The funds have not been earmarked under the Model school scheme State/UT wise. However, the status of Central funds released State/UT-wise under Model School Scheme till 31.3.2015 is annexed.
